There are some misunderstandings about the party's policies. In the process of practicing the basic purpose of the party, there are often slack attitudes, and there is no deep-rooted mass viewpoint and mass line in the mind, Lack of effective practical action. They have not made enough efforts to effectively solve the interests that the masses are most concerned about, have not made enough energy and effort to enhance the trust and confidence of the masses in the party, lack the consciousness and sense of responsibility to the masses, and lack the initiative and enthusiasm to serve the people wholeheartedly.

2.2.4. Personal Ability

The awareness of serving teaching, scientific research and teachers and students is not strong enough. The ability of how to properly use the latest theoretical achievements of the party to analyze and solve problems needs to be strengthened. There is not enough ability and quality to plan for the future, scientific development, correct decision-making and implement.

2.2.5. Honest and Clean

On the one hand, we need to strengthen the daily management, strengthen the monitoring of important areas and key links of the college, and standardize the operation of power. Third, the daily management and supervision system of Party members still need to be further improved. We should establish the system and standard for the important fields and key links of the college, strengthen the behavior management, and comprehensively manage people and affairs according to law in the actual work.
